Office of the High Sheriff:

Judgment Enforcement Registry (JER) Search (from) \$17 plus applicable taxes and JER fee (currently \$35).

Personal Property Registry:

Search (from) \$15 plus applicable taxes and [government fees](#).

Document filing (from) \$25 plus applicable taxes and [government fees](#).

Document filing and discharge (from) \$35 plus applicable taxes and [government fees](#).

Amendment to filing (from) \$25 plus applicable taxes and [government fees](#).

Discharge or Renewal of filing (from) \$15 plus applicable taxes and [government fees](#).

Registry of Deeds:

Basic asset search in a company name entails:

- Confirming registered company name and incorporation date at the Registry of Companies.
- Search in company name from incorporation date at the Registry of Deeds for registered property. Includes confirming registration of any charges or debentures, when requested.

Registry of Companies Options:

Option A: \$17.00 + applicable taxes and disbursements.

A “regular” status report contains information derived from an inspection of the actual company file, as opposed to using information from the Registry of Companies computer index system. This search provides more extensive information (e.g. company name changes, list of predecessor company names which have amalgamated, etc.). Since we inspect the actual company documents in these instances, we are able to guarantee the accuracy of the information provided.

Option B: \$15.00 + applicable taxes and disbursements.

A search of the Registry of Companies computer index only, for the following information;

•company name •company number •incorporation/registration date •registered office •contact name (if given) •year for which last annual return filed •status •list of directors.

Note that oneSource Research Inc. cannot certify the accuracy of information taken from the Registry of Companies computer index.

Volume Discount: For clients eligible for a volume discount (on a minimum of 20 requests per month), subtract \$3.00 from fee for Options A and B.

Company File Document Copy: \$16.00 + applicable taxes and disbursements

A copy of a requested document from a company file, such as a certificate of incorporation, certificate of amendment, registered office or a notice of directors, to a maximum of 4 pages. Additional pages \$.50 each + applicable taxes and disbursements.

Name Confirmation (from computer index only): \$7.50 + applicable taxes and disbursements
